- Events: Boys' & Girls' Singles & Doubles & Mixed Doubles
- Divisions: 8's (ages 6-8, 36' court, red ball), 10's (age 10 & under, 60' court, orange ball), 12's (age 12 & under, 78' court, green ball), 14's (age 14 & under), 16's (age 16 & under), and 18's (age 18 & under)
- Levels: Beginner/Entry Level (must know how to serve & keep score), Intermediate (match or tournament experience) & Advanced (Championship & Super Championship); Note: levels may be combined
- Date: Saturday, December 9 (*Sunday, December 10 may be used if needed for final rounds)
- Location: Memorial Park Tennis Center, 1500 Memorial Loop Drive, Houston TX 77007, 832-395-7561
- Format: Six (6) game set with No-Ad Scoring for 10's through 18's; 8's play 2 out of 3 games to 7 points on 36' courts; Players guaranteed two rounds in singles & doubles
- Fees: One (1) non-perishable food item, gift for needy child or \$5 cash donation per event; or register online for \$8 per event (<http://tennislink.usta.com/tournaments>, ID #800069917, or click [here](#))
- Limitation: Player may only enter one (1) singles and one (1) doubles (NOT two doubles)

- Schedule: Players should call 832-395-7561 after 1 p.m. on Wednesday, December 6 to get their first round match time or check First Match Info Report on tournament homepage; tournament will finish on Saturday if possible, but expect Sunday afternoon matches if big draws or rain
